WHILE DRIVING ALONG INTERSTATE 10, THE FLOORBOARD STARTED SHAKING. WE DECIDED TO PULL OVER TO THE CURB BUT BEFORE WE COULD THE TIRE TREAD PELED OFF. WE SWERVED FOR A BIT AND RESUMED CONTROL OF THE CAR. WE PULLED OVER AND OBSERVED THE TIRE'S TREAD WAS COMPLETELY OFF. THE TREAD WAS LOST ON THE ROAD AND THE TIRE WAS REPLACED AND DISCARDED. I HAVE DOCUMENTATION OF THE DAMAGES AND FOR THE REPLACEMENT TIRE.
