ALTHOUGH THIS TIRE IS NOT INVOLVED IN THE RECALL, I ENCOUNTERED A PROBLEM SIMILAR TO THOSE DESCRIBED FOR THE RECALLED TIRES. THE TIRE, WHICH WAS THREE YEARS OLD AND STILL IN PRETTY GOOD CONDITION, AS FAR AS TREAD DEPTH, COMPLETELY SEPARATED AT THE SIDEWALLS AND DISINTEGRATED RAPIDLY. THE TIRE WAS ON THE REAR OF THE VEHICLE. I WAS DRIVING IN BAJA, MEXICO ON A ROAD THAT WAS PAVED, BUT FAIRLY ROUGH. ALTHOUGH THE TIRE IS NOT PART OF THE RECALL OF FIRESTONE TIRES, THE METHOD OF FAILURE WAS VERY SIMILAR TO THOSE DESCRIBED FOR THE RECALLED TIRES.
