WE HAD JUST DEPARTED HOME AND HAD BEEN ON INTERSTATE 5 IN SEATTLE FOR A COUPLE OF MILES WHEN ANOTHER DRIVER POINTED OUT THAT WE HAD A PROBLEM. WE PULLED OFF THE FREEWAY SHORTLY AND SAW THAT THE REAR DRIVER'S SIDE TIRE WAS IN BAD SHAPE. APPARENTLY, THE FORWARD BIAS OF WEIGHT MADE THIS UNNOTICEABLE TO US. WE HAD NOT SENSED ANY IMPACT WITH A ROAD HAZARD BUT HAD TO ASSUME SUCH HAD OCCURRED. BY THE TIME WE HAD STOPPED THE TIRE WAS COMPLETELY UNREPAIRABLE, BUT I COULD NOT SAY IF IT WAS DUE TO TREAD SEPARATION. THE TIRE WAS SUBSEQUENTLY TAKEN (7/30/99) TO A LOCAL FIRESTONE DEALER WHERE A NEW ATX TIRE WAS INSTALLED. IN LIGHT OF THE RECENT RECALL THIS INCIDENT TOOK ON MORE SIGNIFICANCE IN OUR MINDS AND I HAVE TAKEN THE PRECAUTION OF PURCHASING NEW TIRES (NON-F
