ALL TIRES HAVE VERY VISIBLE CRACKS ALONG THE CIRCUMFERENCE OF EACH TIRES. THE CRACKS APPEAR TO BE GETTING WIDER - NOW IT IS POSSIBLE TO STICK A THUMB NAIL IN SOME LOCATIONS. FOLLOWED THE RECALL PROCEDURE BUT THE EARLIEST THAT I CAN GET REPLACEMENT TIRES IS 7 WEEKS (FROM 9/1) AND EVEN THEN I WAS #100. THESE TIRES APPEAR EXTREMELY DANGEROUS BUT I AM FORCED TO USE THIS VEHICLE TO DRIVE TO WORK - 36 HIGHWAY MILES EACH WAY! WHAT AM I TO DO? *AK
