IT IS A CONCERN THAT AFTER THE FIRESTONE CUSTOMER SERVICE WAS TOLD MY TIRES ARE SHOWING THE SAME SIGNS, THEY DID NOT QUESTION WHICH PLANT MY TIRES CAME FROM. APPARENTLY, THE RECALL SHOULD INCLUDE TIRES FROM OTHER PLANTS. *AK
