WHEN APPLYING THE BRAKES DURING WET ROAD CONDITIONS THE VEHICLE TAKES LONGER TO STOP THAN WHEN IT IS DRY. THE BRAKE SYSTEM MAKES A LOUD NOISE AND THE PEDAL GOES TO THE FLOOR. IT HAS BEEN CHECKED OUT AT THE DEALER AND THEY CANNOT SEEM TO FIND ANYTHING WRONG. THE TIRES ARE ON A DIFFERENT VEHICLE BUT 1 TIRE THE TREAD CAME OFF DURING HIGHWAY OPERATION. DURING INSPECTION WE FOUND 2 OTHER TIRES WITH LOOSE TREAD AND READY TO PEEL OFF. WE HAD THEM REPLACED. THE TIRES HAD SLIGHTLY LESS THAN 10,000 MILES ON THEM WITH A GREAT AMOUNT OF TREAD LEFT

IT HAS BEEN CHECKED OUT AT THE DEALER AND THEY CANNOT SEEM TO FIND ANYTHING WRONG. THE TIRES ARE ON A DIFFERENT VEHICLE BUT 1 TIRE THE TREAD CAME OFF DURING HIGHWAY OPERATION.
