I THOUGHT IT WAS JUST A PROBLEM WITH MY JEEP. IT WAS NOT UNTIL I STARTED HEARING OF MANY OTHER JEEP OWNERS HAVING THE SAME PROBLEM THAT I BECAME CONVINCED THIS IS A MANUFACTURER DEFECT. I BELIEVE A FULL INVESTIGATION SHOULD BEGIN AS I HAVE HEARD OF SEVERAL PEOPLE INVOLVED IN ACCIDENTS RELATED TO THIS DEFECT.
