THROTTLE PLATE AT AIR INLET TO FUEL INJECTION SYSTEM STICKS EACH TIME PEDAL IS INITIALLY PRESSED DOWN FROM A RELEASED POSITION, EVENTUALLY RELEASING WITH SUFFICIENT APPLIED FORCE. THIS CAN RESULT IN A SUBSTANTIAL JOLT IN ACCELERATION FROM A VEHICLE-STOPPED POSITION. SATURN SERVICE CONFIRMS THAT THIS IS A RELATIVELY COMMON PROBLEM, AND IS EASILY REPAIRED AS A MAINTENANCE PROCEDURE.*AK
