I PURCHASED A USED VOLVO WITH A VIRTUALLY NEW SET OF FIREHAWK TIRES ON IT. AFTER DRIVING IT FOR ABOUT 3 MONTHS, I NOTICED ONE OF THE FRONT TIRES HAD DEVELOPED A GOOD SIZED BULGE ON THE SIDE WALL. THIS WAS ABOUT A YEAR AGO. I WAS CONCERNED AND E-MAILED THE CONSUMER DIVISION OF FIRESTONE ABOUT THE PROBLEM. I DESCRIBED THE BULGE AND GAVE DIMENSIONS INCLUDING DIAMETER (APPROXIMATELY 2 INCHES) AND THE HEIGHT OF THE BULGE (ABOUT 1/2 INCH). I ASKED IF IT WAS DANGEROUS TO CONTINUE DRIVING ON THIS TIRE AND WHO WAS RESPONSIBLE FOR REPLACEMENT. I RECEIVED NO REPLY FROM FIRESTONE. EVENTUALLY THE BULGE RUPTURED WHILE I WAS DRIVING AT ABOUT 65 MPH ON AN EXPRESSWAY. FORTUNATELY, THE TIRE DID NOT DEFLATE ALL AT ONCE, ALLOWING ME TO DRIVE /
