PRIOR TO DEMOUNTING THE RIGHT FRONT I INFLATED IT TO DETERMINE WHERE THE AIR WAS ESCAPING. IT APPEARED TO BE ESCAPING IN AN AREA BETWEEN THE TREAD PATTERN. WHEN I DEMOUNTED THE TIRE I INSPECTED THE INTERIOR AND COULD SEE NO EVIDENCE OF A PENETRATION WOUND AND COULD FIND NO TYPE OF FOREIGN OBJECT. IN MY TWO YEARS WORKING AT A TIRE INSTALLATION FACILITY (SEARS) I NEVER ENCOUNTERED A FAILURE OF THIS NATURE.
