THE TIRES ARE COMING APART AT THE TREAD LINE AT THE SIDEWALL. YOU CAN SEE CRACKS AND BUMPS AT THE SIDEWALL/ TREAD LINE, AND PROTRUDING STEEL BELTS. I HAVE ALREADY FILED A COMPLAINT WITH FIRESTONE, BUT HAVE NOT HAD ANY RETURN CONTACT. IT HAS BEEN A MONTH SINCE I FIRST CONTACTED THEM.
