I WAS DRIVING ON A MAJOR INTERSTATE FREEWAY AND THE RIGHT REAR TIRE EXPLODED AND QUICKLY DISINTEGRATED. I SOMEHOW MANAGED TO GET THE TRUCK TO THE SIDE OF THE ROAD AND GET THE SPARE ON. AFTER GETTING TO THE NEAREST FIRESTONE DEALER IN SPRINGFIELD MO, THEY SAID THE FAILURE WAS DUE TO THE RUBBER VALVE STEM BREAKING LOOSE. THEY SAID FORD SHOULD HAVE EQUIPED THE TRUCK WITH STEEL VALVE STEMS. FORD AND FIRESTONE HAVE DECLINED RESPONSIBILITY FOR THE FAILURE. LUCKILY I WAS ABLE TO KEEP FROM CRASHING AND BEING KILLED. *AK
