TOOK TO TOYOTA, SENT TO TIRE KINGDOM AND CHARGED \$46 FOR REPLACEMENT. GOT OFF AND CHECKED, FOUND BUBBLE, TOOK TO TOYOTA, SENT TO PAN AMERICAN TIRE CHARGED \$60 FOR REPLACEMENT. THIRD TIME UNEVEN RIDE, LOUD ROAD NOISE ON HIGHWAY, FOUND BUBBLE. WILL TAKE TO TOYOTA. ALL THREE TIRES WERE ORIGINAL TIRES THAT CAME WITH CAR, SAME BATCH. CONCERNED FOR SAFETY AND DON'T FEEL I SHOULD HAVE TO BE CHARGED FOR MANUFACTURER'S DEFECT. WOULD LIKE REFUND AND REPLACEMENT OF ALL FOUR TIRES. THANK YOU.
