WHEN TRAVELING AT HIGH SPEEDS (70 PLUS MPH) IN CROSSWIND CONDITIONS THERE IS A LOUD "MOANING" AND/OR "WHISTLING" SOUND THAT IS PRESENT IN THE AREA OF THE DRIVERS SIDE DOOR WHERE THE DOOR ASSEMBLY MEETS THE FRAME AND WINDOW ASSEMBLY. THE SOUND IS SO LOUD THAT I HAVE TO TURN OFF THE RADIO BECAUSE THERE IS TOO MUCH NOISE IN THE INTERIOR OF THE CAR TO TALK OR HEAR NORMALLY. I HAVE INFORMED THE LOCAL FORD DEALER AND HE TOLD ME THAT HE HAS THE SAME PROBLEM WITH HIS PERSONAL FORD VEHICLE. FORD CAN'T SEEM TO FIX THE PROBLEM NOR DO THEY SEEM TOO CONCERNED ABOUT IT. THEY (FORD) JUST SORT OF PUT ME OFF AND MORE OR LESS INDICATE THAT BECAUSE THEY CAN NOT SEEM TO CORRECT THE PROBLEM THAT I'LL JUST HAVE TO LIVE WITH IT. THE PROBLEM IS ONGOING AND OCCURS FREQUENTLY WHEN I TAKE
