RIGHT REAR TIRE SHOWS DEFINITE SIGNS OF TREAD SEPARATION. SMALL HAIRLINE CRACK RUNNING AROUND OUTSIDE OF TIRE ABOUT AN INCH DOWN FROM TOP OF TREAD. LEFT REAR TIRE NOT AS NOTICEABLE BUT ON CLOSE EXAMINATION SHOWS SIGNS OF BEGINNING TO SEPARATE. ALTHOUGH TIRE SIZE IS NOT ON RECALL LIST WHEN INSPECTED BY FIRESTONE DEALER THEY AGREED TO REPLACE ALL FOUR TIRES.
