THEY THEN TOLD ME THAT NOTHING WAS WRONG WITH THE TRUCK. SINCE THEN I HAVE EXPERIENCED THIS SUDDEN PULLING AT LEAST 50 TIMES. A FRIEND OF MINE ALSO BOUGHT A NEW 1997 CHEV. P.U. AND HAS HAD THE EXACT SAME PROBLEM. TODAY HE CALLED ME AND SAID THERE IS A WEB SITE DEVOTED TO THIS SAME PROBLEM. ON ICY ROADS AND FOR THE INEXPERIENCED DRIVER, THIS COULD BE A POTENTIALLY FATAL DEFECT. HOW MANY ROLLOVERS AND DEATHS HAVE ALREADY BEEN CAUSED BY THIS UNEXPLAINED STEERING PROBLEM??
