I CHECKED THE OIL LEVEL AND FOUND THAT IT WAS AT THE PROPER LEVEL. I TOOK IT TO THE DEALER WHO SAID I NEEDED A NEW ENGINE. NOW I HAVE APPEALED TO FORD MOTER CO. TO REPLACE THE ENGINE AT THEIR COST. IT SEEMS TO ME THAT THE FAILURE BEGAN UNDER WARRANTY BUT ONLY MANIFESTED ITSELF 3 WEEKS AFTER THE WARRANTY PERIOD.
