I PURCHASED MY 1996 FORD EXPLORER IN NOV. 1995 AND HAVE HAD A VEHICLE SHUDDER PROBLEM THAT BECOMES A SAFETY PROBLEM WHEN TIRES ARE INFLATED BEYOND THE RECOMMENDED TIRE PRESSURE OF 26PSI. FORD HAVE NOW RECOMMENDED TIRE PRESSURES OF 30PSI, WHICH I CANNOT DO WITHOUT RISKING A VEHICLE LOSS OF CONTROL SITUATION. THE FIRST TIME THIS HAPPENED, IT ABSOLUTELY SCARED THE LIVING DAYLIGHTS OUT OF ME, TO PUT IT POLITELY! I HAD JUST PICKED UP THE TRUCK FROM THE MISSION VALLEY FORD AFTER SOME BRAKE WORK. I TOOK THE TRUCK UP TO FREEWAY SPEED AND WHILE TRAVELING OVER SOME ROUGH FREEWAY SURFACE THE TRUCK ALMOST WENT OUT OF CONTROL. I RETURNED TO THE DEALER WHERE FAILURE ANALYSIS WAS PERFORMED. THE ONLY ISSUE THE SERVICE ENGINEER IDENTIFIED AS ABNORMAL WAS THEY HAD SET
