I HAVE THE EXACT TIRE THAT IS BEING RECALLED, THE SAME BRAND AND SIZE BUT BECAUSE IT WAS NOT MADE IN THE DECATUR ILLINOIS PLANT, MY TIRES ARE NOT BEING REPLACED.
