ENGINE OIL SEAL RETAINER WAS OMITTED BY FACTORY. HONDA SHOULD HAVE ISSUED A RECALL, AS THEREHAVE BEEN NUMEROUS INSTANCES OF DEFECT. SEAL RUPTURED WHILE I WAS DRIVING A SHORT DISTANCE AND I SAW OIL POURING FROM ENGINE WHEN I GOT OUT OF THE CAR. DEFECT COULD HAVE CAUSED ENGINE TO RUN DRY OF OIL AND RESULTED IN A CATASTROPHIC FIRE RESULTING IN INJURY OR DEATH TO OCCUOPANTS. HONDA REDUCED COST OF REPAIR TO \$332 , BUT SHOULD HAVE ISSUED A SAFETY RECALL.\*AK
