I PURCHASED A 1999 F150 ON 5/9/00. I RECENTLY BOUGHT NEW TIRES FOR MY TRUCK AND FOUND OUT THAT ONE OF THE WHEELS WAS BENT ON THE INSIDE. THE BEND IN THE WHEEL WAS BAD ENOUGH THAT THE WHEEL COULD NOT BE BALANCED PROPERLY AND WOULD WOBBLE. I THEN PROCEEDED TO PUT ON MY SPARE TIRE AND NOTICED THAT THE SPARE TIRE WAS A DIFFERENT SIZE THAN WHAT WAS ON THE TRUCK WHEN I PURCHASED IT. THE SIZE ON THE TRUCK IS 255/ 70R 16. MANUFACTURER REQUIRED SIZE IS 235/70R/16. I BROUGHT THIS PROBLEM TO THE SELLING DEALER AND SET AN APPOINTMENT FOR THEM TO TAKE A LOOK.
