PONTIAC IS AWARE OF THE PROBLEM BUT WILL NOT CORRECT IT, OF REMEDY IT FOR CUSTOMERS. PONTIAC SHOULD REMOVE GAS GAUGE FROM DASH BOARD SINCE THE SYSTEM IS THIS FAULTY.
