I OWN 2 1987 VW SCIROCCOS, BOTH HAVE HAD SUDDEN AND CATOSTROPHIC TRANSMISSION FAILURE WHICH COMPLETELY DESTROYED THE TRANSMISSIONS, BOTH LOCKED UP ON THE ROAD AND NEARLY CAUSED HORRIFIC ACCIDENTS. THIS PROBLEM EXISTS IN SEVERAL MODELS WITH THIS TYPE OF TRANSMISSION AND HAS BEEN IGNORED BY VW AND VWOA.
