NHTSA RECALL NO. 97V144/ FORD RECALL NO. 97S80. CRACK IN FUEL TANK NEAR HEAT SHIELD ATTACHMENT RESULTING IN FUEL LEAKING FROM TANK. WE CONTACTED FORD AND WERE TOLD THIS RECALL WAS REGIONAL DUE TO CLIMATE. WE FIND THIS UNACCEPTABLE BECAUSE THIS PROBLEM DID INFACT OCCUR IN MASSACHUSETTS ALSO. THIS SHOULD HAVE BEEN A NATIONAL RECALL. FORD SHOULD TAKE RESPONSIBILITY FOR THIS - IT COULD HAVE BEEN PREVENTED HAD THE RECALL BEEN NATIONAL.
