THERE IS SOMETHING WRONG WITH THE BRAKES, I HAVE TAKEN THE CAR TO TWO DIFFERENT SHOPS AND IT STILL MAKES A METALLIC SOUND LIKE SOMETHING IS GRINDING WHEN YOU STEP ON THE BRAKES, THE ODOMETER AND RPM GAUGE WORK INTERMITTANTLY AT BEST PROBABLY SOME KIND OF A SHORT IN THE SYSTEM, WHEN YOU START UP THE CAR THE PASSENGER SIDE WINDOW MOTOR COMES ON, THE WINDOW DOESN'T GO UP OR DOWN BUT THE SOUND IS COMING FROM THE INSIDE OF THAT DOOR, SOMETIMES THE POWERE BUTTONS FOR THE WINDOWS DON'T FUNCTION RIGHT AWAY, YOU HAVE TO TAP ON THE BUTTON SEVERAL TIMES FOR IT TO WORK.
