A/C FAILED PREVIOUS YEAR WHILE UNDER WARRANTY AND DEALER FAILED TO DETECT ANY MALFUNCTION. A/C FAILED EXACTLY 1 YEAR TO THE DAY LATER AND DEALER REFUSED TO REPAIR A/C UNDER DEALER WARRANTY SINCE THEY HAD NOT WORKED ON THE COMPRESSOR THE PREVIOUS YEAR. IN HAVING SEVERAL CONVERSATIONS WITH FORD OWNERS I HAVE DISCOVERED A TREND WITH PROBLEMS NOT ONLY WITH THE HEAD GASKETS, BUT ALSO WITH THE A/C. THIS APPEARS TO BE A TREND IN COMPRESSOR FAILURES WHICH LEADS TO A \$900.00 REPAIR.
