I FORMALLY OWNED A DODGE DAYTONA FOR TEN YEARS...HAD MANY OTHER PROBLEMS BUT IT NEVER BLEW A HEAD GASKET.. I HAVE AN OLDSMOBILE THAT HAS 1400000 MILES ON IT..NEVER NEEDED A HEAD GASKET...HAD THIS HEAD GASKET BLOWN OUT ON A MAJOR HIGHWAY NEXT WEEK ON THE WAY TO MARYLAND, THE ENGINE COULD SEIZE AND COULD HAVE CAUSED A MAJOR ACCIDENT WITH SERIOUS RESULTS ..NOT TO MENTION THE COST OF REPAIRING A "CRACKED BLOCK" THIS HEAD GASKET IS A MAJOR SAFETY HAZARD AS FAR A DRIVING IS CONCERNED AND I FIND IT UNBELIEVABLE THAT CRYSLER
