THERE WERE NO INJURIES. INSURANCE COVERED THE DAMAGE AND ALSO TRIED TO CONTACT MANUFACTURER OF TIRE FOR DAMAGES BUT THEY DENIED ANY RESPONSIBILITY. THE CAR ONLY HAD 12000 MILES AND VERY LITTLE TIRE WEAR AND THE INSURANCE ADJUSTER SAID IT SHOULD HAVE BEEN CAUSED FROM A DEFECTIVE TIRE. THE COMPANY DENIED AND WE HAD TO PAY.
