THE SECOND WAS TREAD SEPARATION WITH LOSS OF A 2" BY 4" SECTION OF TREAD, THIRD TIRE HAS SUFFERED A TREAD SEPARATION APPROXIMATELY 24 INCHES LONG BY 3"-4" WIDE. I DID NOT RECORD THE DOT NUMBER INFORMATION ON THE FIRST TIRE. THE LAST TWO FAILED TIRES SHOW DOT MD11 EXOV 305. (DOT NUMBER: MD11 EXOV TIRESIZE: LT245/75R1)
