LAST YEAR THEY TOLD ME THE PART HAD BEEN REDESIGNED AND I WOULDN'T HAVE ANY MORE TROUBLE. THIS YEAR THEY ADMITTED IT IS UNFIXABLE (EXCEPT BY REPLACEMENT EACH YEAR). TOYOTA REFUSES TO PROVIDE A LIFETIME WARRANTY FOR THE DEFECTIVELY DESIGNED PART. I THINK THEY SHOULD EITHER COVER THE PART FOR THE LIFE OF THE CAR, OR BUY THE DAMN THING BACK.
