I NOTICED A PRONOUNCED REDUCTION IN POWER AND PULLED OFF THE ROAD. I CHANGED THE TIRE AND TOOK IT TO 2 PLACES IN BEEVILLE FOR REPAIR. BOTH ESTABLISHMENTS ADVISED ME TO REPORT THE INCIDENT AS A TIRE FAILURE THAT CANNOT BE REPAIRED. THE TIRE HAS A LITTLE MORE THAN 3000 MILES ON IT. AK
