MY CONCERN IS THAT THE BELT WILL FAIL IN AN ACCIDENT. I HAVE NOT FOLLOWED UP WITH THE MANUFACTURER OR DEALER SINCE. I WOULD LIKE YOU TO INVESTIGATE AND, IF THIS IS A REAL DANGER, ENCOURAGE THE MANUFACTURER TO CORRECT. THANK YOU.*AK
