THE ROLLING OCCURS IN DRIVE OR REVERSE ON EVEN THE SLIGHTEST INCLINE. CHEVROLET HAS NOT RESPONDED TO MY INQUIRES REGARDING THIS ISSUE. I AM CONCERNED THAT THE ROLLING WILL CAUSE AN ACCIDENT.*AK
