WHEN I HEARD A NOISE IN THE REAR OF MY CAR AND REALIZED THAT I HAD A TIRE PROBLEM. AT ONCE I KNEW THAT THE TIRE HAD NOT DEFLATED AND THAT I WAS IN CONTROL OF THE CAR. I REDUCED MY SPEED AND TURNED ON MY EMERGENCY BLINKERS AND COULD HEAR A FLAPPING NOISE COMING FROM THE LEFT REAR.
