A CHUNK OF TREAD ABOUT 12-16 INCHES LONG RIPPED COMPLETELY OFF OF THE TIRE. I THEN HAD TO CHANGE THE TIRE ON THE SIDE OF THE FREEWAY WITH CARS AND TRUCK PASSING ME AT 70 MILES PER HOUR.
