WINDSHIELD WIPER MOTOR WORKS INTERMITTENTLY, ELECTRICAL PROBLEM RELATED TO POSITIONING OF MOTOR(ELECTRIC). I WAS TOLD BY AN AUTOPARTS DEALER THAT THEY HAVE HAD A LOT OF COMPLAINTS OF BAD MOTORS. I KNOW OF TWO FRIENDS WITH SIMILAR VEHICLES (CHEVY BLAZER AND CHEVY S-10 TRUCK) WHO HAVE THE EXACT SAME PROBLEM. WIPERS WILL WORK FINE SOMETIMES AND THEN JUST STOP IN MID-STROKE. I WAS DRIVING IN RAINY CONDITIONS WHEN FIRST OCCURRED. I MOVED WIRING AND THE WIPERS WOULD CUT ON AND OFF, I FOUND THAT IT IS THE WIPER MOTOR HOUSING AND NOT THE WIRES. WEDGED A STICK BETWEEN WIPER MOTOR AND HOUSING AND THEY WORKED FOR A WHILE. THIS IS A COMMON PROBLEM SPECIFICALLY TO THIS STYLE OF VEHICLE AND POTENTIALLY A VERY HAZARDOUS ONE TOO.
