WHEN I ASKED WHY BOTH WOULD NEED REPLACED SO SOON, DEALER SAID "THESE THINGS HAPPEN"; BOTH ISSUES COULD HAVE LED TO MAJOR SAFETY ISSUE. I USE THIS VEHICLE TO TRANSPORT MY TWO CHILDREN, BOTH UNDER AGE 4; THEN DEALER FAILED TO CORRECT BRAKE PROBLEM (LEFT AIR IN THE LINES) WHICH LED TO BRAKES CONTINUING TO LOCK... ANOTHER MAJOR SAFETY ISSUE! I WAS TOLD THE CALIPERS NEEDED TO BE REPLACED AS WELL... BUT BRAKES CONTINUED TO LOCK UNTIL THEY FINALLY DISCOVERED AIR IN THE BRAKE LINES! I THOUGHT THIS MIGHT BE AN ISOLATED INCIDENT UNTIL I CHECKED WITH COLLEAGUES WHO ALSO OWN CARAVAN WITH SIMILAR PROBLEMS... CHECKED NHTSA WEB SITE AND WAS SHOCKED AT THE NUMBER OF SIMILAR
