SEVERE TREAD SEPARATION ON LEFT FRONT. OTHER THREE TIRES SHOWED START OF DETERIORATION. GOOD YEAR DEALER CONTACTED THE MANUFACTURER AND IMMEDIATELY REPLACED ALL FOUR TIRES, ADJUSTING THEM AT 50% REAR AND 45% FRONT. IF DEFECT HAD NOT BEEN CAUGHT, SEVERE INJURY COULD HAVE OCCURRED. SINCE ALL FOUR TIRES WERE DEFECTIVE, I SUSPECT THAT THIS IS NOT AN ISOLATED INCIDENT. I HAVE DIGITAL PICTURES OF ONE DEFECTIVE TIRE.\*AK
