THE ELECTRIC BRAKE WIRING IS DEFECTIVE, FORD HAS FAILED TO FIX THE PROBLEM, I CAN GET THE WIRING REPAIRED FROM A THIRD PARTY, BUT MY CONCERN IS HOW MANY TRUCKS HAVE DEFECTIVE WIRING AND OTHER CONSUMERS ARE BEING PUT AT RISK BY FORD NOT ADMITTING THERE IS A PROBLEM WITH THERE TOW PACKAGE WIRING.
