WITHIN 16 MONTHS HAVE HAD TO REPLACE LEFT REAR BRAKE DRUM 3 TIMES BECAUSE THE DRUM GETS WARPED OUT OF ROUND. THE MECHANIC HAS INDICATED THAT ON THAT PARTICULAR GM STYLE CAR, THIS HAS BEEN A COMMON PROBLEM, INDICATING THAT THE PARTS MAY NOT HAVE BEEN MANUFACTURED WITH SUFFICIENT STRENGTH TO WITHSTAND THE BRAKING. THE LAST OF THE 3 TIMES WAS ONLY 3 WEEKS AFTER THE PREVIOUS REPLACEMENT. AK
