NO ONE STRUCK, INJURED OR KILLED, BUT DAUGHTER AND BABY COMING HOME JUST MISSED BEING HIT. EXTENSIVE BODY DAMAGE REQUIRING MINIMUM OF 3 SEPARATE TRIPS TO AUTO BODY SHOP.
