NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE RETURN SPRING FOR THE REAR BRAKE SHOES IS INADEQUATE. ON TWO OCCASSIONS THE RIGHT SIDE SPRING CAME LOOSE AND WAS DESTROYED BY THE AXLE SHAFT RUBBING AGAINST IT. WHEN THIS HAPPENS THE REAR BRAKES ARE LOST AND ONLY THE FRON BRAKES WOK, RESULTING IN THER PEDAL GOING ALMOST TO THE FLOOR. THE MOST RECENT INCIDENT HAPPENED TO THE BRAKES ON THE LEFT SIDE. THE BRAKES CAME LOOSE AFTER USING THE PARKING BRAKE, WITH RESULTANT LOSS OF REAR BRAKES AND ONLY FRONT BRAKES WORKING, PEDAL ALMOST TO THE FLOOR. THIS TIME THE SPRING DID NOT BREAK AND THE BRAKE PARTS WERE REINSTALLED.
