### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

APPROX 5MIN OF DRIVING AT RESIDENTIAL SPEEDS ENGINE WOULD CUT IN AND OUT AS IF RUNNING OUT OF GAS. THE FUEL GAUGE REGISTERED ABOUT 1/3RD FULL. FIRST TRIP TO THE DEALER FOUND TWO TROUBLE CODES: SP0440 & P0171. WAS TOLD TO TIGHTEN GAS CAP AND RETURN IF PROBLE PERSISTS. WITH FULL TANK OF GAS AND AT HIGHWAY SPEEDS ENGINE CUT OUT AND BACK IN CAUSING QUITE A JOLT. PROBLEM CONTINUED ESPECIALLY WHEN ACCELERATING. BACK TO DEALER (ONE WEEK AFTER 1ST VISIT) TO FIND OUT FUEL PUMP NEEDS REPLACING. FOUR MONTHS OUT OF WARRANTY, BUT LOW MILEAGE, SO I COMPLAINED TO DEALER. "GOODWILL" REPLACEMENT BY MFG ALTHOUGH OUT \$220 FOR 2 TRIPS INTO DEALER FOR PROBLEM SOLVING.\*AK
