DEALER SAID ROTORS NEED TURNING- AT 8000 MILES? PROBLEM REOCCURED 6 MNTHS LATER AT 15000 MILES-HAD A BROAD BLADE LATHE CUT AT A DIFFERENT DEALER. FIRST DEALER WANTED TO CHARGE ME AND THEN SAID THEY DID NOT HAVE RIGHT EQUIPMENT TO FIX IT. PROBLEM REOCCURED AGAIN AT 19000 MILES. HAD ROTORS AND HUBS REPLACED. HAD TO FIGHT TO GET WARRANTY TO FIX IT. HOPE THIS WORKS THIS TIME. WHEN BRAKES VIBRATE IT FEELS UNSAFE. *AK
