HOW MANY PEOPLE ARE DRIVING AROUND UNAWARE THAT THEIR SEATBELTS ARE SUBJECT TO FAILURE, BECAUSE OF A MAJOR USE EARLIER? THERE IS THE CONCEPTION THAT IF A SEATBELT GOES AROUND AND HOOKS THE PERSON IS SAFE, FALSE, FALSE, FALSE..... THEY ARE NOT DESIGNED FOR MULTIPLE USES.
