I WISH TO HAVE HARLEY RECALL THE BIKES RATHER THEN ISSUE A 5 YR / 50,000 EXTENDED WARRANTY ON THE BEARING. IT DID NOT HAPPEN TO MY BIKE YET. BUT REPORTS IN MAGAZINE AND ON THE WEB INDICATE THAT CAM BEARING FAILURES ON CERTAIN 1999-2000 HARELY ENGINES ARE OCCURING. THE WEB INTEFACE HERE WOULD NOT LET ME FILE UNLESS I PUT NUMBERS IN. SO, I PUT IN NUMBERS IN IN ORDER TO GET A MESSAGE TO YOU. AGAIN IT DID NOT FAIL ON MY PARTICULAR ENGINE. I SPEAK FOR I DON'T KNOW THE EXACT NUMBERS OF BIKES THAT HAVE FAILED ACCORDING TO MAGAZINE ARTICLES AND THE WEB, AND EVEN HARLEY HAS FINALLY EXTENDED THE WARRANTY BUT I FEEL THAT IS NOT GOOD ENOUGH.
