FIVE DAYS AFTER THE PURCHASE RADIATOR CRACKED, CAR OVERHEATED, TOOK TO DEALERSHIP, WHILE SPEAKING WITH THE SERVICE MANAGER, I EXPLAINED THE ABS/TRACTION CONTROL LIGHT CAME ON AND STAYS ON AS OF 3RD DAY AFTER PURCHASE AND THAT THE ENGINE WAS SURGING AND BACK FIRE TYPE NOISE FROM UNDER THE HOOD DURING ACCELERATION AND THE CAR HAD NO POWER. THE FRONT RIGHT FOG LIGHT WAS NOT WORKING THE DAY OF PURCHASE AND TO REPLACE IT, I WAS CHARGED FOR THE REPLACEMENT BULB. THERE WAS NO BUYERS GUIDE ON THIS VEHICLE ON THE DAY I TEST DROVE THE CAR NOR ON THE DAY OF PURCHASE, I PURCHASED A ONE YEAR EXTENDED WARRANTY THROUGH THE DEALERSHIP IN THE AMOUNT OF \$1295.00, AND WAS TOLD IT COVERED EVERYTHING.
