INTAKE MANIFOLD GASKET - NEEDED REPLACED WITH LESS THAN 70K MILES ON VAN. HEATER FAN DASHBOARD SWITCH - WHEN SET ON FLOOR HEAT ONLY, IT BLOWS OUT BOTH AT THE DEFROSTER AND THE FLOOR. WINDSHIELD WIPER MOTOR - AFTER IT STOPPED WORKING, WE GROUNDED THE MOTOR AND IT STARTED WORKING AGAIN - NOW IT WORKS INTERMITTENTLY, BUT NOT WHEN YOU USUALLY NEED IT MOST. DRIVER'S SIDE WINDOW MOTOR - FAILED AND REQUIRED REPLACEMENT. AIR CONDITIONING TUBE - BECAME BRITTLE AND BROKE - REPAIRED IT AND THE A/C WORKS CORRECTLY AGAIN.
