I AM A MEDIUM SIZED SCHOOL BUS FLEET. WE FOUND THE ABOVE VEHICLE HAS BOTH FRONT FRAME RAILS CRACKED. THIS DEFECT WAS FOUND DURING A ROUTINE PM INSPECTION. WE IMMEDIATELY INSPECTED 20 OTHER SCHOOL BUSES OF THE SAME VINTAGE IN OUR FLEET. WE FOUND 3 ADDITIONAL BUSES VIN# 1HVBBABN0SH201963, 1HVBBABN7SH201958, 1HVBBABN1SH201955, EACH BUS HAS A CRACKED FRAME RAIL NEAR THE REAR ENGINE MOUNT. ALL BUSES HAVE BEEN PLACED OUT-OF-SERVICE TILL THEY CAN BE REPAIRED BY THE DEALER. I HAVE RESEARCHED THIS WITH SEVERAL OTHER BUS CONTACTORS, I HAVE FOUND ONE CONTRACTOR THAT HAD 7 CRACKED FRAMES ON THE SAME MODEL BUS. ANOTHER WHO HAD SEVERAL ALONG WITH ONE THAT RECRACKED AFTER BEING REPAIRED BY AN INTERNATIONAL DEAL
