I HAVE HAD BRAKE FAILURE ON THIS VEHICLE SINCE I BOUGHT IT. THE BRAKES WOULD LOSE HOLD AND THE VEHICLE WOULD LURCH FORWARD AS IF IT WERE ON ICE. I WAS ABLE TO AVOID COLLISIONS THROUGH LUCK AND ALSO BY BEING VERY AWARE OF THE PROBLEM AND LEAVING EXTRA SPACE BETWEEN THE VEHICLE IN FRONT OF ME. VARIOUS DEALERS MISDIAGNOSED THIS PROBLEM SEVERAL TIMES. FIRST TIME, FRONT BRAKE JOB, SECOND TIME, REAR BRAKE ADJUSTMENT. THIRD TIME, THEY SAID THE PUMP WAS BAD. MIRACULOUSLY THE WARNING LIGHT CAME ON FOR THE VERY FIRST TIME IN THE DEALERSHIP. \$900 LATER I HAVE A NEW ABS PUMP. NOW THE TRUCK PULLS TO THE RIGHT. IT DID NOT DO THIS BEFORE. DEALER SUSPECTED THAT THE ABS PUMP WAS DEFECTIVE. UPON REPLACEMENT, THE TRUCK STILL PULLS TO THE RIGHT. TH
